### Summary of the proceedings of the 32<sup>nd</sup> AGM of the Members of the Company held on June 27, 2025

The 32<sup>nd</sup> AGM (“**the Meeting**”) of the Members of the Company was held on Friday, June 27, 2025 at 11:00 A.M. (IST) through video conferencing / other audio visual means at the registered office of the Company in compliance with the provisions of the Companies Act, 2013 (“**the Act**”) and rules made thereunder read with relevant circulars issued by the Ministry of Corporate Affairs, Government of India. The meeting is deemed to be conducted at the Registered Office of the Company at Times Square Building, E-Wing, 4th Floor, Opp. Mittal Industrial Estate, Gamdevi, Andheri Kurla Road, Marol, Andheri (East), Mumbai - 400059, Maharashtra.

Ms. Savita Mahajan, Independent Director chaired the Meeting other than for Agenda Item no.7. For Agenda Item no. 7, Mr. Amit Gainda, Managing Director & CEO chaired the meeting.

10 members (including 5 authorized representatives of non-individual shareholders) were present at and throughout the Meeting. Representative from Statutory Auditors was also present during the meeting.
